- To help Veterans and Servicemembers with service connected disabilities to prepare for, find, and maintain suitable careers
- For those with service-connected disabilities so severe that they cannot immediately consider work, VR&E provides services to improve their ability to live as independently as possible





Active Duty Servicemembers:

- Honorable discharge expected upon separation from active duty
- VA Memorandum or DES rating of 20% or more
- Servicemembers participating in IDES and who have been referred by the PEB coordinator

Veterans:

- Honorable or other than dishonorable discharge
- VA Memorandum or DES rating of 20% or more
- VA service-connected disability rating of 10% with a serious employment handicap or 20% or more with an employment handicap

The VR&E Process



- Application
- Entitlement Decision
 □ Evaluation and Planning
- Tracks
- Employment Services
- Rehabilitated

- Application received (VONAP or 28-1900)
- Veteran's eligibility established (GED processing used to establish pending 719)
- · Schedule veteran for initial counseling appointment if eligible

- · Work with veteran to identify track
- Establish vocational or independent living goal
- · Define services needed
- Develop written plan of services

- On-going case management (max of 18 months)
- Provide employment services
 - VetSuccess.gov
 - Interview skills
 - Job placement assistance
 - Referral to DOL

- VRC meets with veteran
- Conduct VR&E orientation to include Five Tracks Video
- Conduct vocational evaluation to assess skills, abilities & interests
- Determine employment handicap (VR&E entitlement criteria) and serious EH
- Determine feasibility for employment

Indep. Living (24 mo. max with 6 mo. Ext by VR&EO)






- Workload FY 2012


Average Beginning Professional Salary - \$37,741



Outreach/Early Intervention





VetSucess on Campus Program





- VR&E Service is committed to providing early outreach and intervention to Servicemembers and Veterans
 - Integrated Disability Evaluation System (IDES)
 - VR&E's Coming Home to Work (CHTW) Program
 - VA Assistance Program (VAAP)
 - VetSuccess on Campus (VSOC) Program





- During FY13, VR&E will continue to expand its outreach efforts to Servicemembers and Veterans by increasing VRC's participation through collaborations with DoD through:
 - Yellow Ribbon Reintegration Program (YRRP)
 - Post-Deployment Health Reassessment (PDHRA)
 Program





- VR&E Service also holds regular staffings with DoD at the national level to promote this initiative
- At the local level, VRC's are working with:
 - Recovery Care Coordinators
 - Support service agenciea
 - VA Military Services Coordinators
- Through these partnerships we educate Servicemembers about changes in the law, the MOU and VR&E services available to them
- Physical Evaluation Board orientations, TAP and DTAP briefings are also used as forums to educate Servicemembers

Integrated Disability Evaluation System (IDES)



Purpose

- Provides onsite VR&E outreach and transition services to active duty Servicemembers transitioning from military to civilian duty
- Range of Services
 - ➤ Mandatory meeting with VR&E counselor when referred to Physical Evaluation Board (PEB)
 - ➤ Comprehensive evaluations
 - Career counseling to identify career goals and commence VR&E services

IDES (cont.)



 Early engagement in rehabilitation and/or education services by physically placing VRCs at IDES locations

• History:

FY 2011: Tested concept at four sites

- FY 2012: Added 48 sites to serve an additional

12,000 existing Servicemembers, Guard

& Reserves

 FY 2013: Adding 95 staff to serve an additional 10K Servicemembers at the largest of the remaining 139 sites





- On October 1, 2011, IDES implementation was completed
- All Servicemembers entering a medical discharge program in any service are placed into the IDES process, ensuring receipt of a rating decision prior to separation and eliminating breaks between military compensation and VA disability compensation
- In FY 2012, 48 new IDES sites were created





- The Department of Defense and the Department of Veterans Affairs entered into a Memorandum of Understanding (MOU) in February 2012
- Eligible Servicemembers are referred to a Vocational Rehabilitation Counselor if:
 - it has been determined that there injury or illness could lead to a referral into the Integrated Disability Evaluation System (IDES),
 - if they are being processed through the IDES and are being referred to a Physical Evaluation Board or
 - are assigned to a Service's Wounded Warrior program and are participating in the Education and Employment Initiative (E2I) program.



Early Intervention Benefits

Assist the recovery process

 Provide for an easier transition and reintegration into a civilian career





- VR&E is participating in the next Voice of the Veteran survey in an effort to help assess Veteran satisfaction with their services
- Pending adequate resources, satisfaction surveys will be built into VR&E's new case management software





Purpose

- To ease the transition of Servicemembers to Veteran-student status by providing coordinated delivery of benefits and services
- Maximize retention and graduation rates for Post 9/11 GI Bill participants
- Pilot began in June 2009 at University of South Florida (1,176 Veterans)





- Initiative expanded to 7 additional sites by FY 2011
- Program to expanded to 32 sites by FY2012
- During FY 2012: The campuses served by VSOC had a combined Veteran population of 32,000 Veteran students who could access on-site supports

VetSuccess.gov



Purpose

- Comprehensive employment resource for all Veterans
- Agencies can post job openings directly on VetSuccess.gov
- Job board currently connects over 190,000
 Veterans with over 5,000 registered Employers
- Veterans have access to millions of jobs through VetSuccess and its Veteran job database
- Employers can search existing Veteran resumes for direct placements, such as:
 - Security Clearance
 - ➤ Degree
 - ➤ Skill type

- VetSuccess.gov Enhancements
 - State-specific resources searchable through map feature
 - Military Skills Translators
 - Interviewing skills tips
 - Job hunting tips
 - VetSuccess news
 - Resume development tools
 - Theme pages
 - ➤ VetSuccess on Campus, At Home, In the Community, In Transition, At Work, and For the Veteran's Family





- All job feeds from USAJOBS.GOV, Job Central, CareerBuilders.com, and Monster.com will automatically populate the VetSuccess.gov job board
- provide our Veterans with a centralized location to find and apply for both federal and private sector careers
- Direct verification of a Veteran's occupational and disability status through integration with eBenefits.va.gov, allowing the Veteran to self-manage his/her claims information
- Social media, resume posting, as well as searching and aggregation of job opportunities



VetSuccess.gov Redesign



(cont.)

- Multiple resources and tools to assist Veteran in self assessing skills and to prepare for and succeed in training, work, and self-employment
- Linkages to mentoring resources for various occupational groups, including self-employment
- Success stories and Veteran feedback mechanisms
- Easy access to information about all VA business lines and services, including user friendly access to selfservice functionality
